The DLT was provided with an overview of the components of Schoology (Learning Management System) that was board approved to support both home and school learning.
4. Hays CISD Grading Policy for Home and School Learning-Kevin Malandruculo
Grading will be consistent with the Hays CISD Grading Guidelines and practices used for in-person instruction. It is important to note that students will be assigned grades for both in-person and online learning; the assignment of Pass or Incomplete (P/I) was a special provision for the Spring Semester of 2020 only.
5. Health and Safety Updates-Macie Walker and Jeri Skrocki

To address the current health and safety guidelines, a committee was created to create protocols for the following: safety, screening, isolation, face coverings, physical barriers, transportation, hand washing/sanitizing, campus visits, spacing in the classrooms, arrival and dismissal procedures, movement in the building, recess & special areas, cleaning and training. The committee was given an overview of these guidelines which are based on recommendations from the Centers for Disease Control and Prevention and local health guidelines. The guidelines are subject to change based on new guidance from health officials.
6. Reopening School Task Force: Overview of School Models-Dr. Wright
Dr. Wright provided an overview of recent COVID 19 statistics and possible options for school structure for the 2020-2021 school year.
Option A: Keep the adopted calendar following TEA guidelines.
Option B: Keep the adopted calendar and start school virtually for three weeks. (Consideration for in-school learning would be given to students without internet access.)
Option C: Change the calendar to move the first day of school to September 8, 2020. The first three weeks would be virtual. The last day of school would be June 16, 2020.
(Consideration for in-school learning would be given to students without internet access.)
7. Discussion of School Models
Dr. Wright answered questions that were submitted in writing as well as questions from the committee members.
8. Voting on School Model for the 2020-2021 School Year

The DLT Committee submitted electronic votes: Option A-0 votes, Option B-85.3% votes, and Option C-14.7% votes.
