*Ms. Courson reviewed the details of the DOI Plan. This plan was shared at the September DLT meeting, on the district website, and via the DLT October meeting invitation. There are no proposed changes to the DOI plan since amendments were approved by the DLT and Board of Trustees in the spring of the 2022-2023 school year. At this time, the district is proposing to extend the current plan for an additional 5 years. The voting members of the DLT were asked to vote on whether they were in favor of extending the DOI as proposed for an additional 5 years. 35 of 38 voting members were present at this meeting. All voting members who were present were in favor of extending the DOI plan for an additional 5 years.*
4. District Improvement Plan  
*Ms. Norris presented information about the DIP and the CNA process. DLT members were asked to participate in a gallery walk of the DIP strategies. All DLT members rotated around the room to review the various strategies. DLT members had an opportunity to ask questions to the C&I staff person stationed at strategies, and DLT members were asked to give written feedback on the DIP strategy posters. Members were encouraged to review the DIP in its entirety following the meeting and send additional input to Stephanie Norris. District staff will review the feedback, and the DIP draft will be updated and submitted to the Board.*

5. State and Federal Grants: [Use of Funds](#) Review

*Ms. Norris shared information with the DLT about the district's proposed use of Federal grant funds and its State Compensatory Education allotment. The DLT members asked questions about some of the use of funds. Norris encouraged DLT members to review the information and share any feedback that they or their teams might have about the use of funds.*
