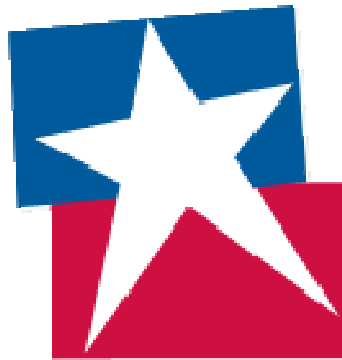

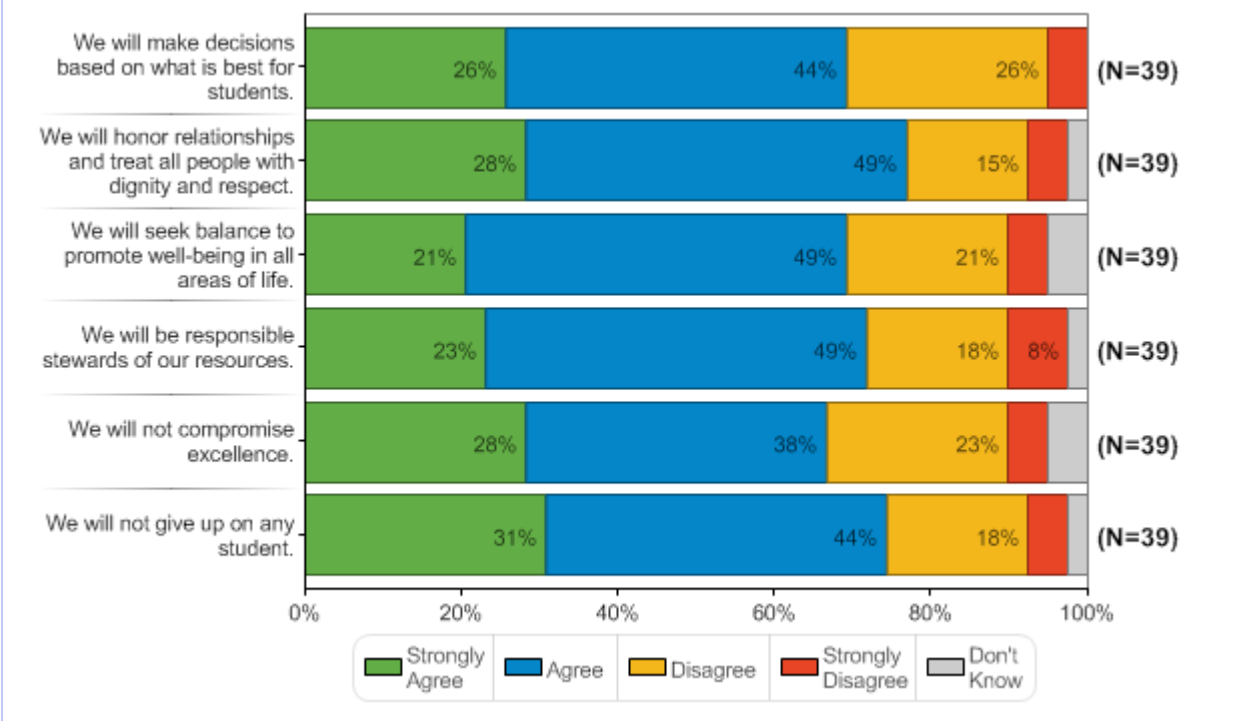

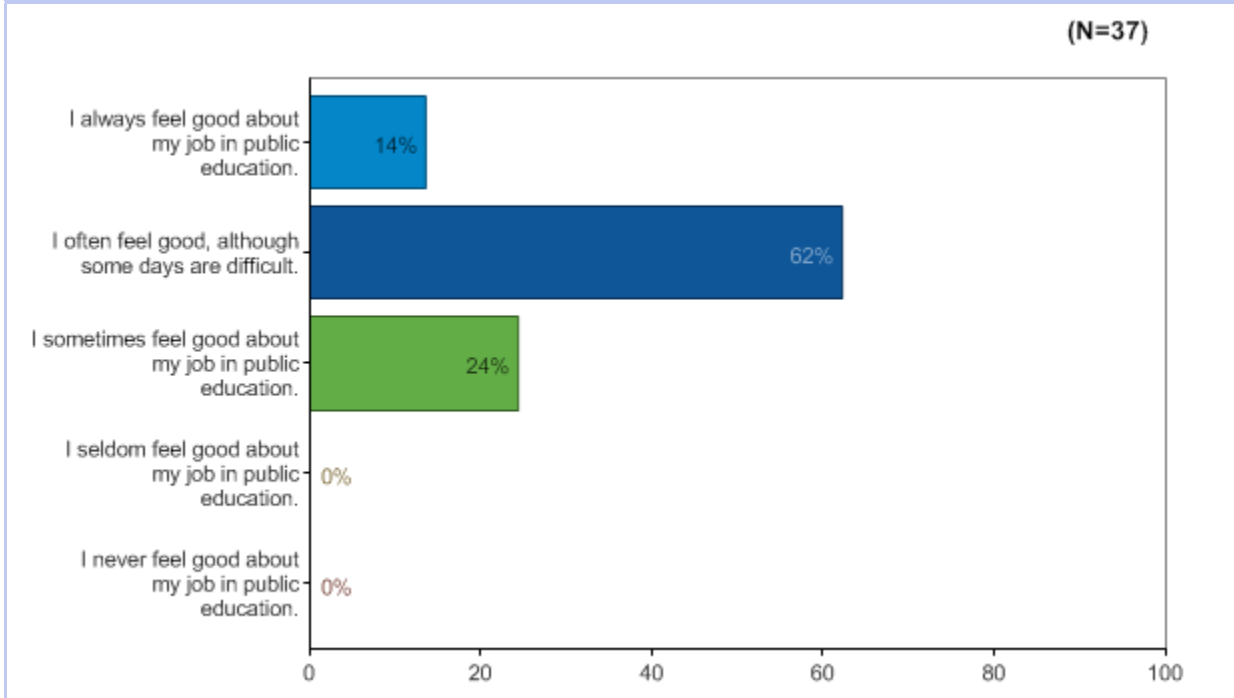

How strongly do you agree or disagree with the following statement?



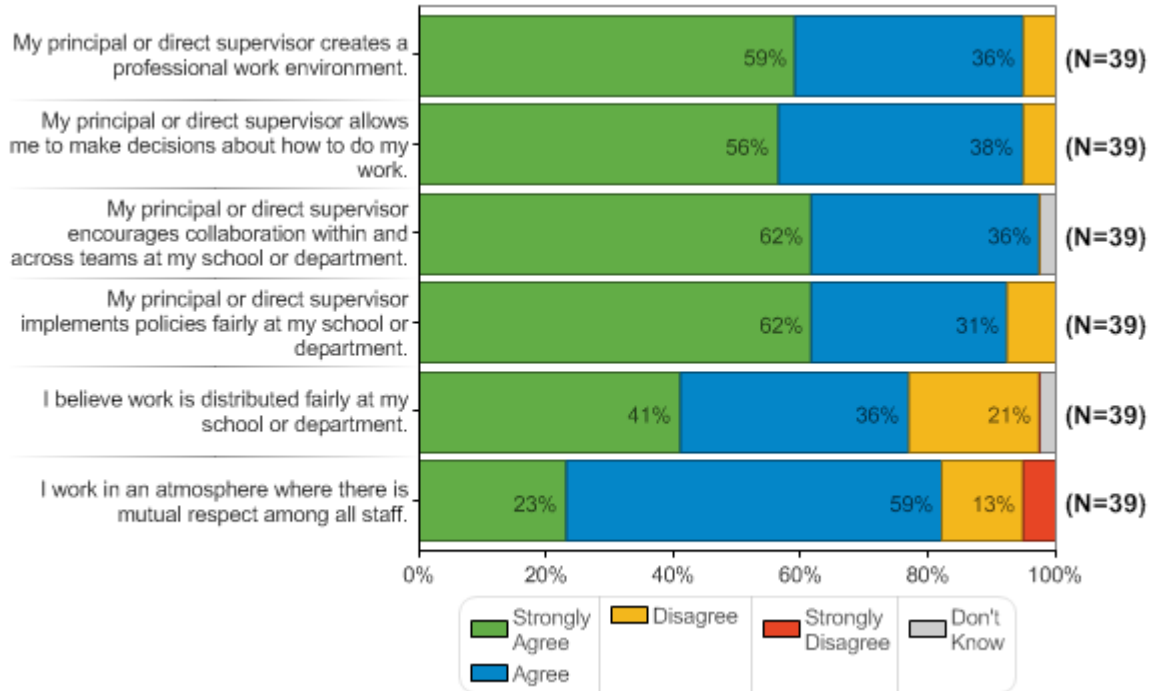
Overall, how do you feel as an employee in a public school system?

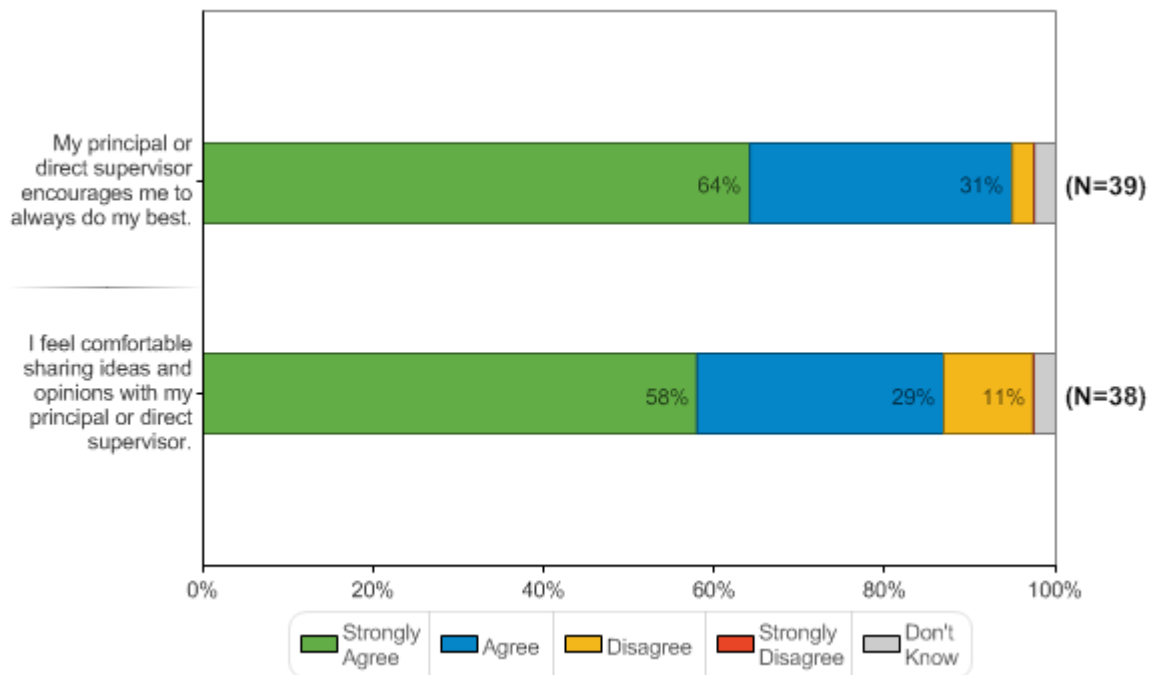
How strongly do you agree or disagree with the following statements?

Shared values are an important part of a highly effective, successful school system. Please read each statement below and consider your experiences this school year.

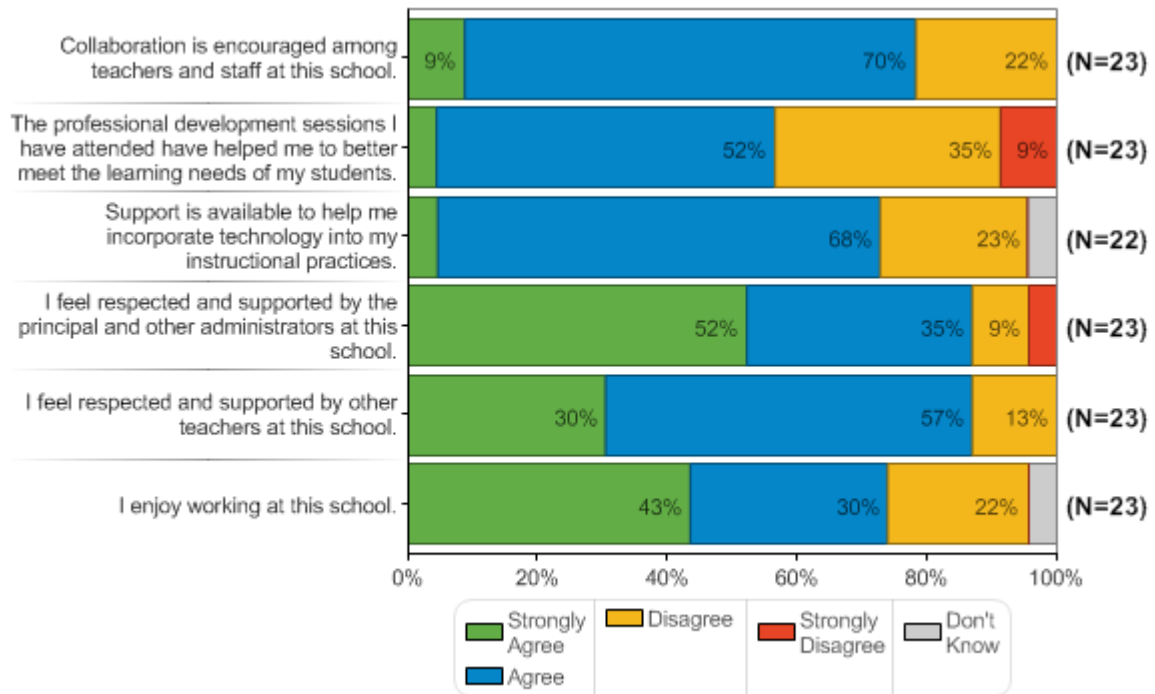
How strongly do you agree or disagree with the following statements?

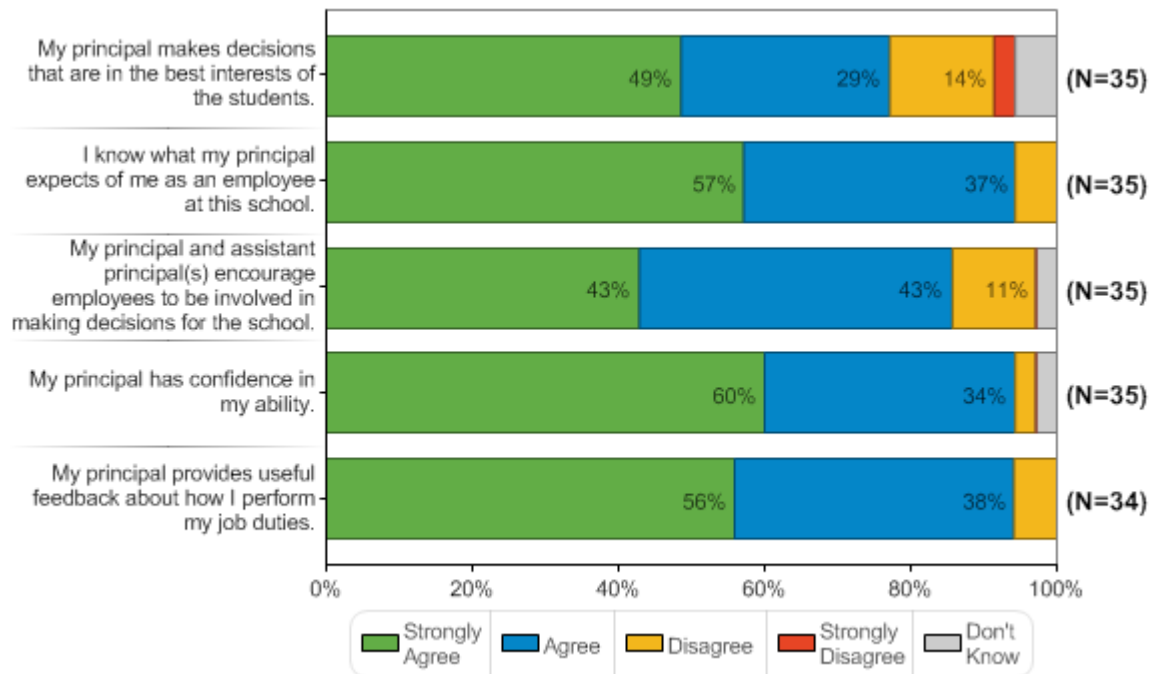

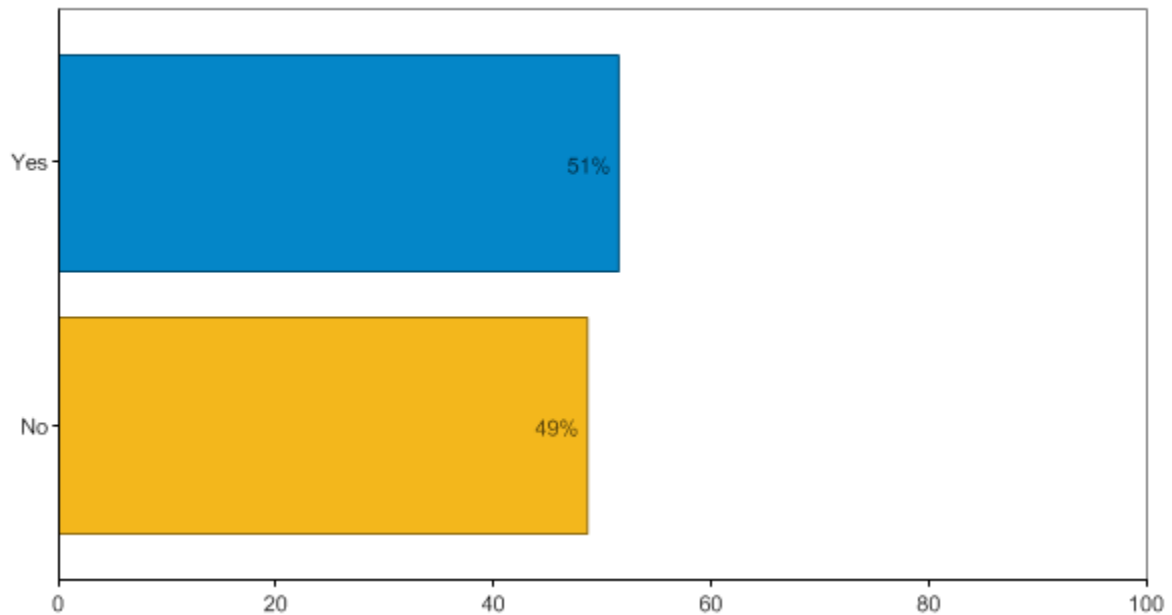

Have you had an issue or concern to discuss with your principal or assistant principal this year?

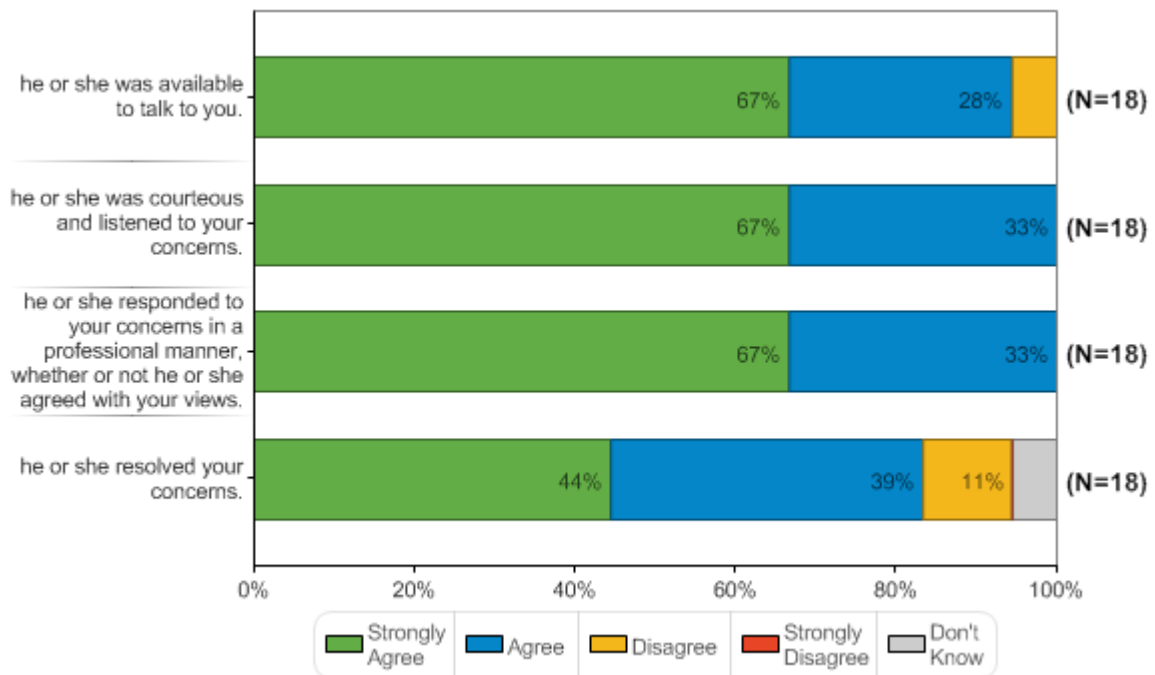

How strongly do you agree or disagree with the following statements?

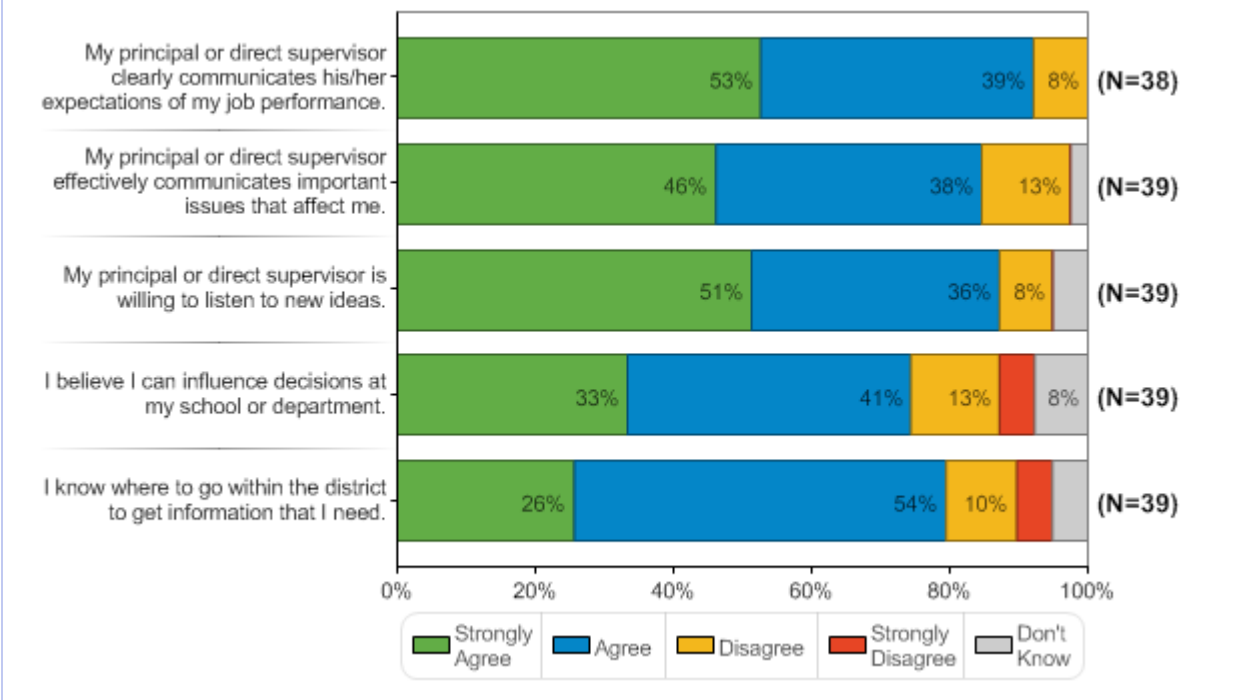

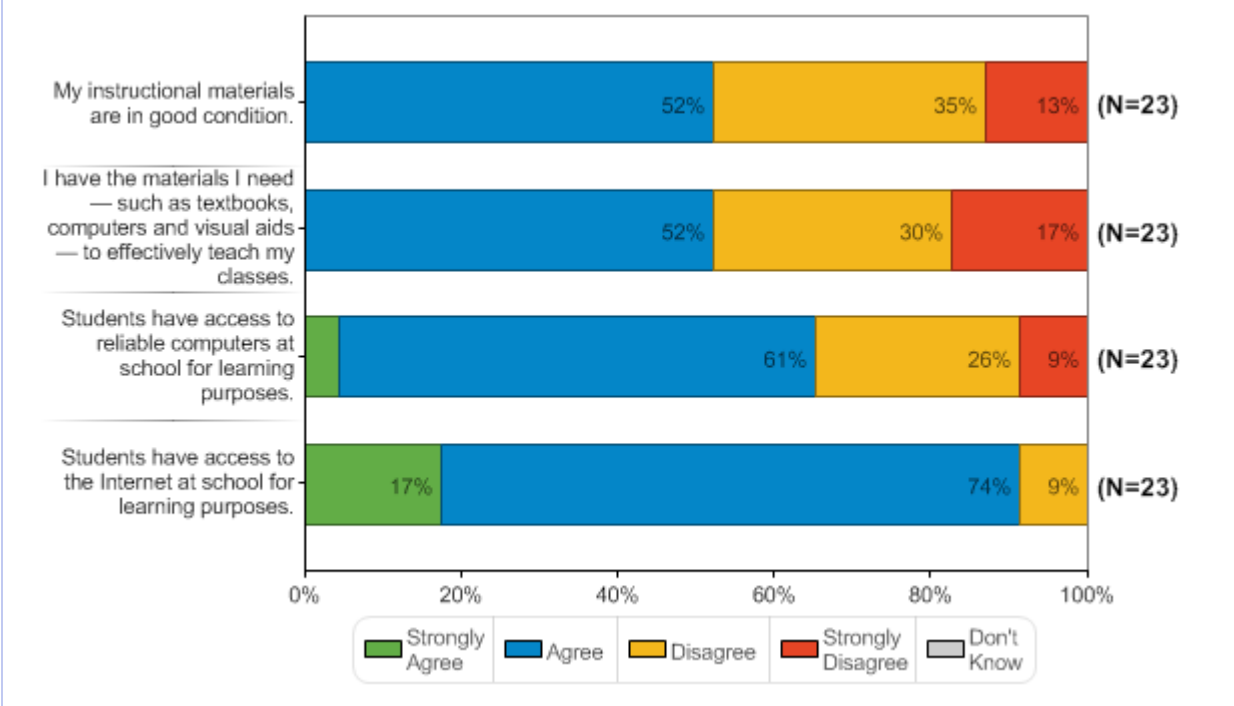

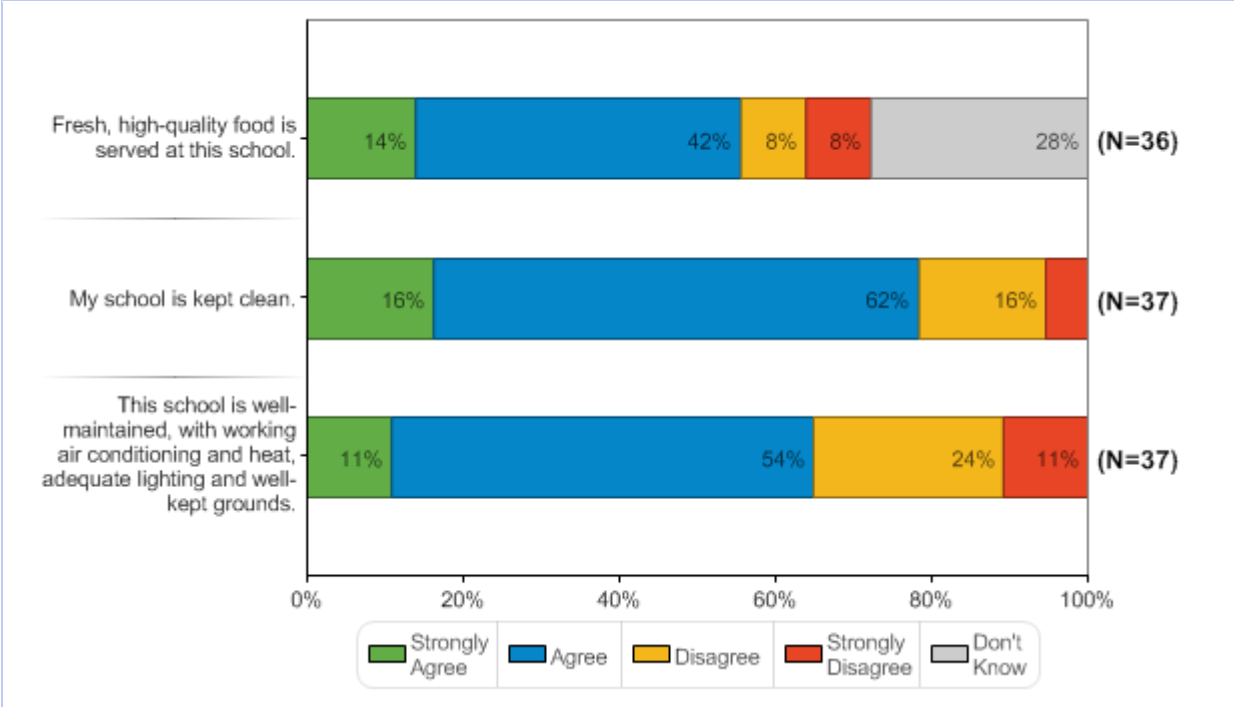

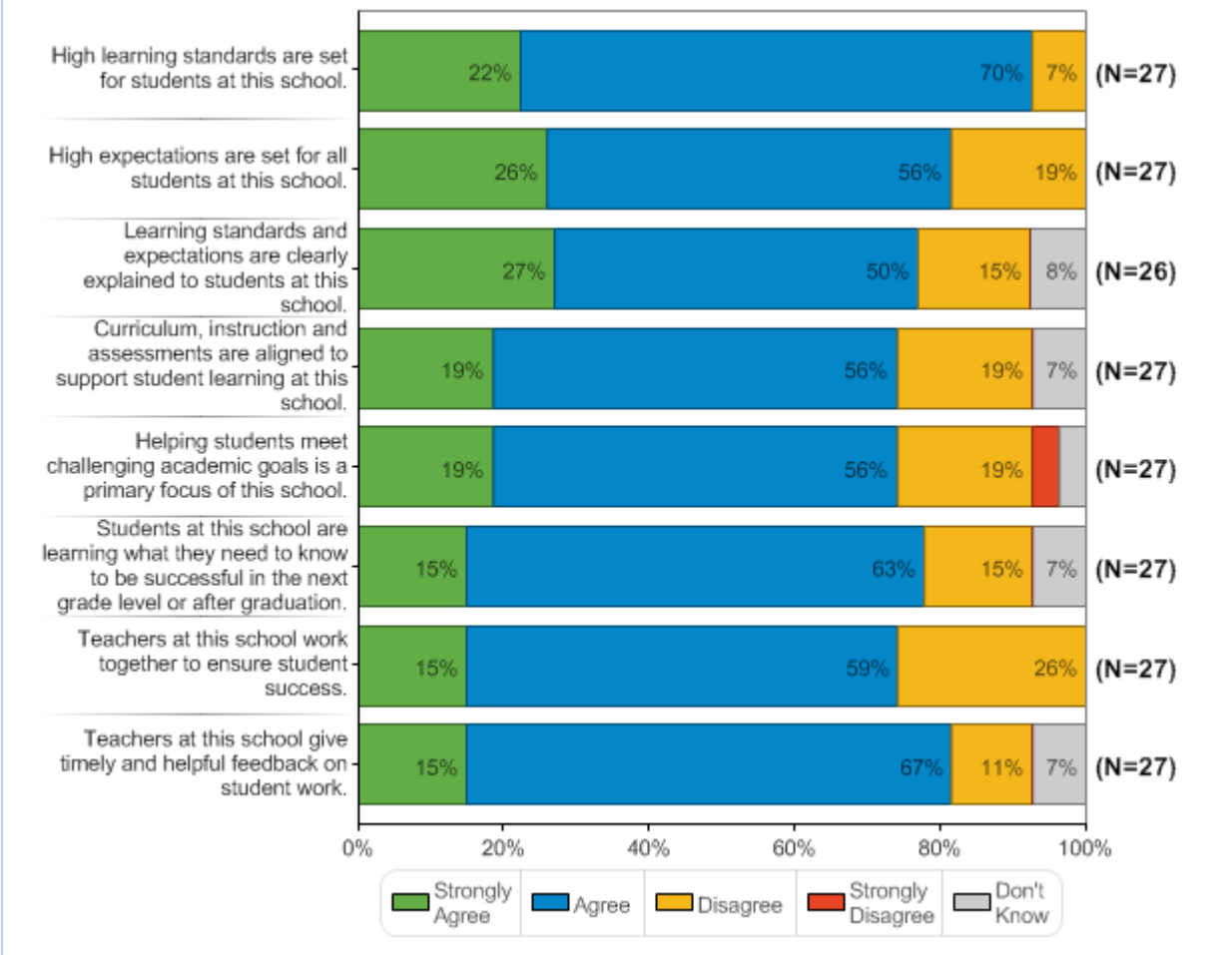

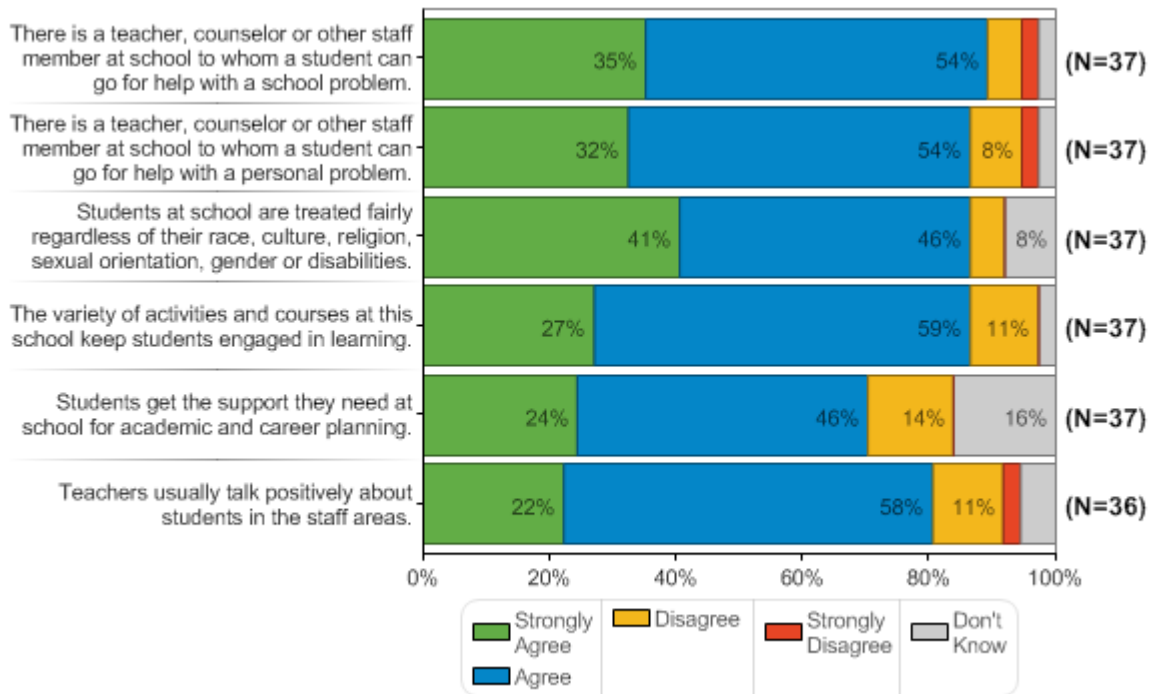

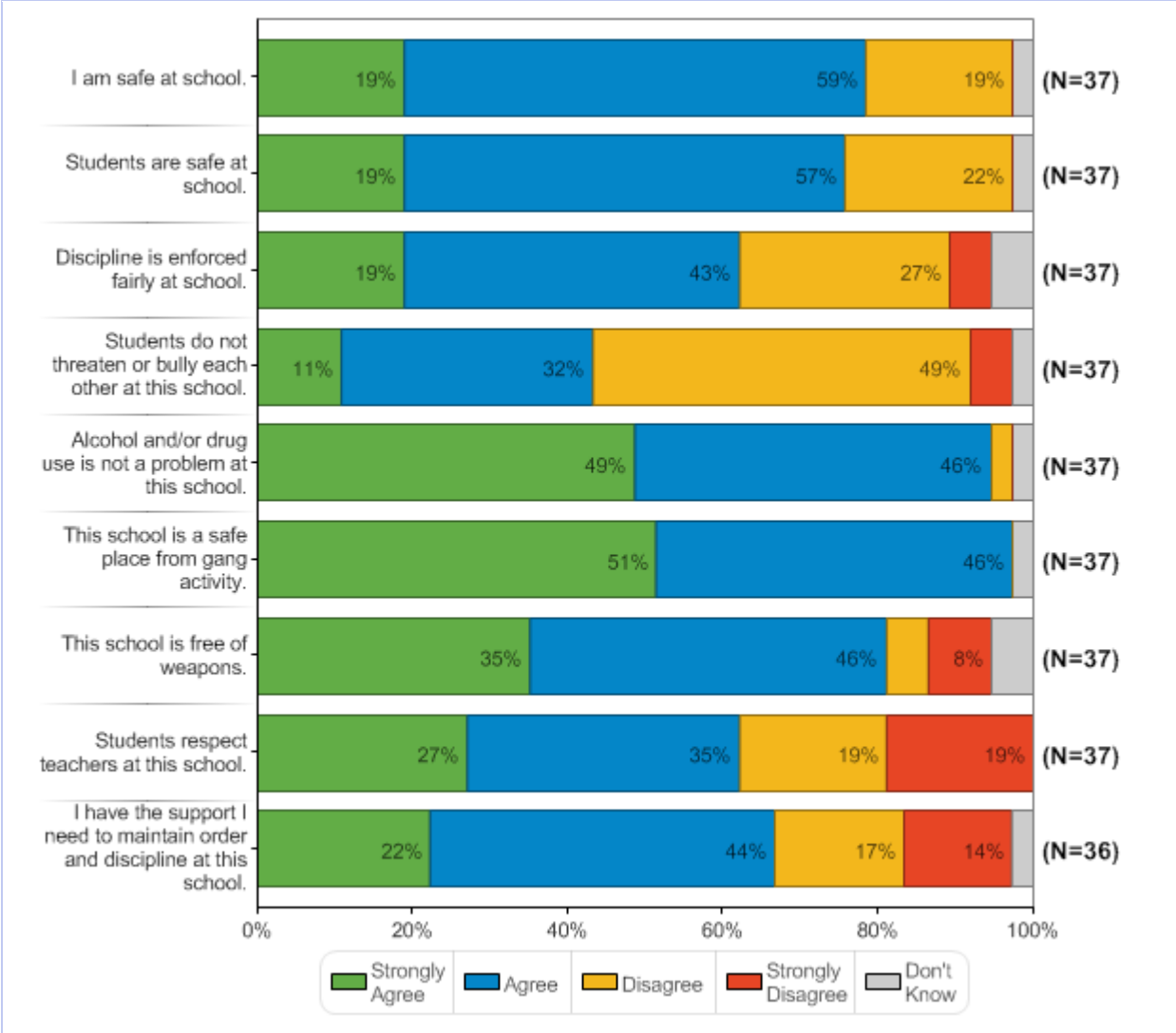
